# **About License Term and Software**

A license is required to use the software.

A licenses is obtained using the "License Tool" (**\*1**) For details on how to obtain a license, please refer to the "License Tool Manual" included in the software.

\*1: A free license is provided at the time of product purchase.Obtain (activate) this license using the License Tool.

In addition, the license has a validity period.

Within the license period, you can use the latest software for PALMiCE, CodeRecorder, and C-Shark, and the latest supporting devices for FP-30.

In the case of FP-40 or FP-10, the "license registration date" is the basis, not the "license period. You can use devices that are compatible with the software version released as of the license registration date. Details are explained on the following pages.



## For PALMiCE, CodeRecorder, and C-Shark


You may use any version of the software released up to the license expiration date.

If the license period has expired, although the latest version of the software can be downloaded from the download site, you will not be able to use it.

For example, in the figure below, all versions of the software prior to "Ver. 1.00.01" can be used, but "Ver. 1.00.02" and later released after the license expiration date cannot be used.



However, it can be used by extending the license period. To use them, the license period has to be extended.





#### About the User Support System

This system allows you to use the latest software by making technical inquiries and licensing the product within the support period. When you purchase the product, it comes with a free support period of the user support system. The free support period is 3 months from the date of purchase. A paid one-year support period may be added.


### For FP-40, FP-10

Software version upgrades can be performed anytime regardless of the license registration date.

However, supported devices are determined by the license registration date as well as the software version. The following is a description of available devices, using FP-40 as an example. (Please refer to the same section for users of FP-10.)

• FP-40① : [Flash memory A][Flash memory B]

**In case of FP-40**(1), flash memory A and B supported by C-Flash Ver. 1.00.00 and Ver. 1.00.01 can be used since they were released before the license registration date.

Support for Flash memory C is added after the license registration date, so it cannot be used even if C-Flash is upgraded to Ver. 1.00.02.

**In case of FP-40**②, flash memories A, B, and C that are supported by C-Flash Ver. 1.00.00, Ver. 1.00.01, and Ver. 1.00.02 can be used since they have were released before the license registration date.

By purchasing and registering a CPU update license, the license registration date will be updated, allowing you to use devices that were not available.

#### For FP-30


Software upgrades can always be performed regardless of the license expiration date.

However, supported devices are determined by the software version as well as the validity period of the license. FP-30 comes with a free 12 month license when it is purchased.

For example, in the figure below, the available devices are as follows:

• FP-301 : [Flash memory A][Flash memory B]

**In case of FP-30**(1), Flash memory A supported in C-Flash Ver. 1.00.00 can be used from the beginning. Since C-Flash was upgraded to Ver. 1.00.01 within the license period and since C-Flash Ver 1.00.01 provides support for Flash memory B, Flash memory B can be used.

Flash memory C support is added in C-Flash Ver. 1.00.02, but the license has already expired. So, even if C-Flash is upgraded to Ver. 1.00.02, Flash memory C cannot be used.

**In case of FP-30**(2), both Flash memory A and Flash memory B supported in C-Flash Ver. 1.00.01 can be used from the beginning. Subsequently, Flash memory C support is added in C-Flash Ver. 1.00.02. If the license term has been extended, Flash memory C can be used just by upgrading the C-Flash version. Otherwise, Flash memory C cannot be used.

Thus, by extending the license period, devices that cannot be used due to expiration of the license can be used. The period can be extended by purchasing a license option.
